Policy for selection

As per the institution norms quotations are invited by reputed vendors who are known for their success in the ERP field. Based on the requirement of the college and the quotations given by the vendors, suitable vendor is chosen. The college then asks them to develop/modify ERP software that suit our needs. Until recently we used MyGurukul software for the better management of both academics and administration of the college.

The college has now decided to use Campus Technology Software developed by Kahan Technology. The selected ERP helps us provide simpler and efficient system of governance within the institution, it is decided to adopt and implement e-governance in functioning of all Departments and their activities.

E-governance has been implemented in various areas of operation. These areas of operation are illustrative and the Governing Body has the rights to implement or withdraw.

- 1. Website: College Website is the mirror of the college and should provide all the necessary information about the college. It should reflect activities of the college which are already completed and those which are to be conducted in future. Students rely on college website as their one-stop-shop to learn about the college. College needs to make sure the content on the websites is up-to-date and enables prospective students and existing students to get the information they need. Students choose the college on the basis of information that appears on the website. College must high light all its positive points and showcase them through their website.
- Student Admission: The College accepts applications from students in both online and offline mode to both UG and PG programs in all disciplines. College does not accept cash but students are advised to pay fees through Vijaya Bank. All financial transactions are cashless. Every aspect of the expenses incurred by the student is considered and fees for the same, is collected once.
- Accounts: To facilitate maintaining accounts easily the college is already using necessary software. But, with new accounting methods and compliances, it has become necessary to procure other software as well. Appropriate security measures should be taken for maintaining transparency in financial transactions. College has competent staff, which is well versed in using technology for better governance. Training to the existing staff and updating of the existing software is done regularly. Employees' salaries are disbursed electronically and messages for the same with e-pay slip are sent to all the employees.

- Library: We have the privilege of having one of the best libraries. To continue with this legacy, we regularly update our learning resources. Every year college should purchase both books and e-learning resources to cater to the growing need of the updating syllabi. The college makes sure that the library is equipped with all e-libraries like INFLIBNET and OPAC. Apart from OPAC, web based services for both students and faculty members are provided which enables them to utilize the library resources effectively. Similarly newer e-learning resources like journals pertaining to all disciplines are identified and are subscribed based on the request and recommendations of both the students and the teachers.
- Administration: To provide hassle free and convenient management of both academic and administrations the college uses effective ITC method. Data base of the students is maintained by the mentors of the concerned departments. Students' attendance is maintained electronically and parents are informed if their wards abstain from attending the classes immediately. Their academic progress is also maintained through ITC.
 - All major administration is carried on electronically. Students' records are maintained and disbursed electronically. Teachers leave and other administrative matters are managed through e-mails.
- Examination: As per the directions of the University, it is mandatory to handle examination through online mode. Examination forms are filled online and fees is paid online directly to the University by the student. Admit Cards to the examination centers and the venue is communicated to the students by the university directly. Students receive their marks statements of both their internal assessment examination and the University examination online.
- 7. Alumni: In order to strengthen alumni interaction, a separate alumni portal is created. Alumni are in touch with their Alma Mater through social media like Instagram, Face book and WhatsApp. Alumni database is maintained and alumni activities are organized regularly.
