The objective of an SAP value-added course for BCom and BBA students is to learn SAP FICO (Financial Accounting and Controlling) is an essential module in the SAP ERP system that handles financial data and accounting processes for businesses. This 30-hour lesson plan aims to provide participants with a comprehensive understanding of SAP FICO, covering key concepts, functionalities, and practical applications. The course is designed to equip learners with the necessary skills to effectively manage financial accounting and controlling tasks within an organization.

This report outlines my experience and achievements in the SAP class I undertook. The course aimed to help students gain proficiency in the SAP FICO (Financial Accounting and Controlling) module. Throughout the training, specific objectives were set to ensure a thorough understanding of SAP FICO concepts and practical applications. This report highlights how each objective was met and its impact on my learning and professional development.

Specific objectives of SAP course for BCom and BBA students:

Objective 1: Understanding SAP FICO Fundamentals

The primary objective of the course was to establish a strong foundation in SAP FICO fundamentals. This included learning about the module's role in the ERP system, key terminologies, and the integration between financial accounting and controlling processes. The instructor successfully delivered comprehensive lectures and engaging discussions that provided a clear understanding of the core concepts.

The course covered various reporting and analysis tools within SAP FICO. I gained proficiency in generating financial statements, customizing reports, and extracting data for decision-making purposes. Objective 5: Applying SAP FICO in Real-Life Scenarios

One of the key objectives was to apply SAP FICO knowledge to real-life business scenarios. The course incorporated practical case studies and projects that required problem-solving and critical thinking. Working on these assignments with fellow students allowed me to experience the challenges and complexities of financial accounting and controlling in a simulated business environment.


